Quality Work Strand

Gillian Martin then presented a secretariat discussion paper on the quality work strand, which included options regarding new funding streams, how such streams may operate, their advantages and disadvantages, and the role of providers and the State as a result. The Expert Group then discussed the paper, and the main issues covered included: staff pay; pay structures; CPD; staff retention; the relationship between providers and the State; funding conditionality; data availability; qualifications and training; and operational quality measures.

Stakeholder Consultation

Nick Fitzpatrick from Frontier Economics presented an update on the planning and structure for Phase 3 of the stakeholder consultation. The Expert Group then discussed the outcomes of

consultations thus far through Phases 1 and 2, the proposal for Phase 3, ideas on how best to facilitate constructive dialogue and output from the upcoming consultation, and the objectives of Phase 3.

Childminding

Matthew Duffy presented a secretariat discussion paper on Childminding and the New Funding Model. The main issues covered in the discussion included the nature of childminding, National Action Plan for Childminding (2021 - 2028), and considerations regarding the incorporation of childminders into the New Funding Model.
