The Chair presented the Draft 2 of the Report and led a discussion which covered issues including its structure, framing, costings, evidence and data presentation, the impact of Covid-19, timelines and phasing.

#### NCS 12 Month Review

Gillian Paull from Frontier Economics presented the findings of the NCS 12 Month Review. This consisted of an overview of the evidence collection for the review, its findings regarding scheme structure and implementation, early findings on the impacts of the NCS, as well as concerns for further consideration. Thomas Baily, also from Frontier Economics then gave a presentation on the aspect of the NCS commonly knowns as the Work/Study Test. This covered the policy rationale, design, and aims of the test as well as an overview of trade-offs including those related to flexibility, sustainability, and the administrative burden.

The Expert Group then discussed the NCS 12 Month Review and the implications of its findings for their Report on the New Funding Model and for ELC and SAC sector more broadly.
